#### Chairman's Message

Wow, a lot can happen in a month! In case you had your head firmly planted under a rock, there is a new federal administration in town. Rather than try to cover all of the possible changes anticipated for the aggregates industry, here are a couple to book-end the past month:

On January 20, 2017 – the same day President Trump was sworn into office – White House Chief of Staff Reince Priebus issued a memorandum to freeze all new and pending federal regulations. The memo stated agencies cannot send new regulations to the Office of the Federal Register — necessary for the finalization of new rules — until Trump's administration has agency leaders in place to approve these rules. Importantly, the memo also stated regulations sent to the office but not yet published in the federal register need to be withdrawn. (Historical note: former President Obama issued a similar memo in 2009 after he took office.) This will hopefully include MSHA's final workplace exam rule, which was announced on January 17 and was due to be published in the federal register on January 23. That's right – after a multi-year process, MSHA may have missed enacting this rule by three days, including a weekend.

On February 17, 2017, Scott Pruitt was confirmed to head the EPA. Long a vocal and active opponent to the agency he will now lead, his confirmation should make good on Trump's promise to "get rid of [the EPA] in almost every form." Case in point: as Oklahoma's Attorney General, Pruitt filed a lawsuit against the EPA for the waters of the United States (WOTUS) rule, which would expand interpretation of federal jurisdiction to include waters within 4,000 feet of "navigable waters", including dry stream beds and isolated wetlands. Interpreting "navigable waters" has always been a slippery subject thanks to the original Clean Water Act of 1972 not adequately defining what "navigable water" is. His and other challenges raised by states, as well as agricultural and industry groups, led to a judicial stay of the rule for further hearings. With Pruitt now confirmed as the EPA head, we can expect the WOTUS rule will be removed.

OIAA Sponsored Part 46 Training has been scheduled in Roseburg on March 20<sup>th</sup> and in <u>Albany on March 21<sup>st</sup></u>. This year's classes will be taught by Adele Abrams law team Josh Schultz, Esq. CMSP and Michael Peelish, Esq. Both are practicing attorneys in Adele's Law Firm.

Josh has taught the class with Adele in the past few years and is also certified as a Mine Safety Professional by the ISMSP and is active in the National Safety Council's Young Professionals Division. He's also chair of the Colorado Stone Sand & Gravel Assn safety committee and is on their board of directors. Before becoming a lawyer, he worked at a family cement plant.

Michael has been litigating MSHA cases for mine operators, and also has headed safety departments at both coal and metal/nonmetal mines from Colorado to WV. He oversaw Alpha's settlement with MSHA of the multimillion Upper Big Branch mine disaster, after alpha assumed Massey liabilities. He does safety and health audits for our clients, including a lot of work doing IH sampling and evaluating workplaces for silica issues and controls, for the new OSHA silica standard. He just got back from doing safety audits at some Mexican mines in December 2016.

# If you missed OIAA sponsored Safepro training last December, Dean Beam will be holding another law institute June 5<sup>th</sup> thru 9<sup>th</sup> in Savannah Georgia.

Understanding the laws and regulations that govern the mining industry is vital to managing your compliance and safety programs. \$afepro covers the 1977 Act in detail along with 30 CFR and program policies which give guidance to how the laws and regulations are to be enforced. The Safepro Institute will give you the knowledge, coupled with your mining experience that allows you to be prepared for the imminent MSHA inspection. Nothing works if your house isn't hazard-free. The Safepro institute information will help you avoid bad citations based on the inspector's imaginary hazard scenarios.

We will cover the new Workplace Examination Rule which can be found on the Federal Register. The most significant changes require operators to have a "competent person" conduct working place examinations to identify hazards before work begins in an area, notify affected miners of hazardous conditions that are not corrected immediately, and promptly initiate corrective action and record the locations examined, the adverse conditions found, and the date of the corrective action.

The new standard increases the potential issuance of citations and opens the door for heightened enforcement. Operators may now see citations for failing to make records available, failing to correct a hazard properly, failing to document the corrective action, failing to document the adverse condition, failure to notify miners, failure to conduct the examination before work begins in the area. With these changes it will allow MSHA to bring heightened enforcement and larger fines and the threat of criminal accusations. This Safepro institute will prepare you with a understanding of the law which will let you meet the inspector on equal terms. Attorney Adele Abrams will have the latest legal news concerning MSHA and will answer questions.

The Safepro institute will be held in Savannah,GA June 5-9 2017 at the historic downtown Hilton Garden Inn. Our hospitality room will be open every night after class for you and a guest if your company allows. We offer meals, drinks and fellowship with your classmates and trainers. Applications will be directed to the scholarship selection committee. Scholarship recipients will be notified in writing by the OIAA and the recipient's name will be listed on the OIAA website. Those who do not receive scholarships will also be notified by mail.

Unless otherwise noted, the scholarships shall be in the amount of \$ 2,500.00 each as a onetime award.

All recipients will be required to write a short letter of thanks to the OIAA and present it in person at a designated Board Meeting. By attending such meeting you indicate your acceptance of the award and the terms of the scholarship.
