Without a Board to run the organization, OIAA will cease to be, including the annual MSHA training sessions so many of you attend. But besides the annual training, there is much more we all enjoy through OIAA:

- A source of unity and strength for independent operators;
- A platform to provide important news and developments in the industry;
- Associate members with expertise to help operators navigate difficult permits, compliance, and negotiations;
- Other training opportunities to help you run your business and understand its complex relationship with overseeing agencies.

The frustrations leading to the association's formation in 2008 may seem to have subsided, but it would not take much to change things. While MSHA may be foremost in the minds of many members, recall that the governor nearly removed DOGAMI as an agency this year. With every change of administration, there is an opportunity for reinterpretation of regulations or introduction of new policies. That is when

industry associations show their greatest value. But building OIAA took a lot of effort. It would be a shame to lose this association to atrophy.

The need for industry representation and advocacy is still important. The permitting and regulatory environment for mining will continue to become more complex. It takes associations like OIAA to communicate those changing rules to members so they can prepare themselves.

New, inspired leaders are needed to carry on the mission. As we look to the future of the industry and the organization, we welcome the opportunity for similarly inspired members to join the Board. Your ideas, perceptions, and experiences help us guide our activities for the betterment of all members.

Government agencies work for you, a citizen of our country. Sometimes the interpretation of a rule becomes unclear or muddled. Sometimes enforcement of a rule becomes overly enthusiastic. Sometimes the agency which is taxed (literally) with applying regulations feels an inflated worth and loses sight of its original mission. Sometimes an inspector capriciously changes interpretation of rules between inspections. Sometimes agency employees exercise a personal vendetta that impacts the very right of an individual to operate their business. Sometimes Federal administrations change due to national elections, followed by directives which radically change the rules (some call it moving the goal posts).

Back in 2008, all of these things actually happened in the aggregate industry in Oregon.

However, speaking strictly for myself, I'm getting old, and I want to pass the torch to someone who will continue to uphold the mission we began several years ago. We were able to defend our members and to work with the regulators to reduce tensions and promote good practices that benefitted everyone.

History has a way of repeating itself. It would be a shame if we in the mining business take our eyes off the ball and allow past troubled times to return. When things are going fairly smoothly it is easy to become complacent. Please don't let that happen now. OIAA is at a crossroads. We continue to provide annual refresher training and support members with solutions to problems that arise. To

continue helping our industry we need new members to step up and keep our membership informed. The Directors meet 4 times per year; sometimes in person, sometimes virtually. We listen to our membership 365 days per year and help when asked. Will you be the person to step up and give back to your industry advocate?
