### Chairman's Message

Hope you all enjoyed the eclipse, partial or total, it was a fantastic sight. In mining-related news:

**WOTUS Update** – The EPA is asking for your input! As mentioned in previous newsletters, a "recodification" rule was proposed by the EPA to define Waters of the United States (WOTUS) using preexisting standards instead of the expanded definition under a 2015 WOTUS Rule, currently in suspension thanks to a judicial stay. The EPA's 2017 proposed rule is the first step toward establishing the "…appropriate scope of waters of the United States."

Please submit comments online by <u>September 27<sup>th</sup></u>. It is important for miners to speak up about how the 2015 WOTUS Rule would impact their livelihood and create an inappropriate expansion of federal jurisdiction.

**MSHA has New (Temporary) Leadership** – Wayne Palmer will serve as acting assistant secretary to head MSHA, as announced by Secretary of Labor Alexander Acosta on August 21<sup>st</sup>. MSHA had been without a director since Joe Main left the office in January 2017. Palmer's previous experience includes being chief of staff for the Department of Labor. The temporary appointment does not require confirmation by the Senate. A permanent candidate is expected to be announced soon and will undergo the typical(?) confirmation process.

**METAL/NONMETAL MINE FATALITY** – On July 27, 2017, a miner was fatally injured when his lightduty truck was run over by a haul truck. The victim was pronounced dead at the scene.



#### **Best Practices**

 $\cdot$  Do not park smaller vehicles in a large truck's potential path of movement.

 $\cdot$  Before moving mobile equipment, be certain no one is in the intended path; sound the horn to warn possible unseen persons; and wait to give them time to move to a safe location.

 $\cdot$  Ensure all persons are trained to recognize workplace hazards - specifically, the limited visibility and blind areas inherent to operation of large equipment and the hazard of mobile equipment traveling near them.

 $\cdot$  Establish procedures that require smaller vehicles to maintain a safe distance from large mobile equipment until eye contact is made or approval to move closer is obtained from the mobile equipment operator. Provide training on these procedures.

- · Install cameras and collision avoidance systems on large trucks to protect persons.
- $\cdot$  Regularly monitor work practices and reinforce their importance. Take immediate action to correct unsafe conditions or work practices.

This is the 7th fatality reported in calendar year 2017 in metal and nonmetal mining. As of this date in 2016, there were 10 fatalities reported in metal and nonmetal mining. This is the 2nd Powered Haulage fatality in 2017. There were two Powered Haulage fatalities in the same period in 2016.
