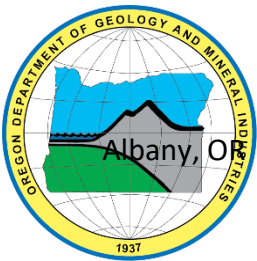
And as always, thanks for your support of OIAA. Best of luck to you in 2024!

DOGAMI Update

Vaughn Balzer and other DOGAMI staff will be attending our February 7th board meeting. In addition to introducing new hires at their agency, Vaughn will provide a summary of a proposed rulemaking and be available to answer questions. The rulemaking is regarding the appeals process for DOGAMI actions other than contested cases. More details are due the first part of January 2024.

DOGAMI Update to OIAA

DOGAMI wanted to provide the following updates to OIAA. In addition, I am happy to attend the next OIAA meeting on February 7 to provide more details and answer any questions. Note that I will invite DOGAMI's new hires (see below) to the meeting, however I won't be able to confirm their attendance until closer to the meeting date.

Updates:

1. **Rulemaking OAR 632-030-0056: "Appeals Process For Orders In Other Than Contested Cases"**
Rule Summary: This rule is being amended to align the rule text with Oregon Revised Statute 517.880. The Department's intent when issuing a suspension order is to prevent adverse impacts adjacent properties and/or the environment by requiring the immediate suspension of mining operations at any surface mining site where the operator has not complied with or is not complying with the operating permit, reclamation plan, or Oregon Administrative Rule Chapter.

The rule change only applies to Suspension Orders. Note that most permit compliance issues are resolved prior to DOGAMI issuing a Suspension Order. Currently there are only 13 Suspension Orders in effect.

The official Notice will be published on January 2, 2024, and will include the rule text that is proposed to be changed and provide the details on how to make comments during the Public Comment period. DOGAMI will share the Notice with OIAA once it has been published.

2. DOGAMI Staffing Update:

- a. Melissa Carley (MS, GIT) joined MLRR as our new Aggregate Permitting Reclamationist on Monday July 10, 2023.
- b. DOGAMI has a new Mining Geologist starting in January. DOGAMI will introduce the new hire after they have been formally on boarded.

3. **Pending Stormwater Training:** Lisa Reinhart of DOGAMI is participating in a stormwater training on February 1 at Chemeketa Community College in downtown Salem. OCAPA is sponsoring the training, however, the training is open for non-members to attend. There is also a Certified Erosion and Sediment Control Lead (CESCL) training with an optional Field Day the day before in Albany OR that may be available at a discounted rate for those who attend the training on February 1. The stormwater Best Management Practices training and CESCL training will be posted on the OCAPA website (<https://www.ocapa.net/>) approximately 1 month in advance.
