Chairman's Message

OIAA held its workshop on the new **OSHA Crystalline Silica Rule** on February 23, 2018. Adele Abrams provided a summary of what employers should expect, important elements for compliance, and insights from her experience and cases she has already defended because of the rule. The short version is the federal OSHA will now consider a permissible exposure limit (PEL) of 50 micrograms per cubic meter (μ g/m³) to crystalline silica averaged over an 8-hour work day. The new PEL is 20% to 50% of previous PELs used by OSHA for various industries. The "action level" that would require employers to enact a compliance program with the new rule is ½ again of the new PEL, or 25 μ g/m³. Compliance will include exposure monitoring, medical exams, written plans for managing exposures, and engineered controls for tasks that put employees at risk of exceeding the PEL. This rule is already in effect for the construction industry and will become effective for general industry on June 23, 2018.

While this rule comes from OSHA, and MSHA has not (yet) adopted it, mine sites could have employees that fall under both OSHA and MSHA standards, depending on the types and locations of their work. We encourage our members to become familiar with this new rule and prepare for compliance. Also, be aware that Oregon OSHA plans to adopt the new rule on July 1, 2018.

Adele will share her presentation materials with us, which will be posted on the OIAA website in March. Many thanks to her for an informative workshop!

MSHA's Top 10 Most Cited Standards at Surface Metal and Nonmetal in 2016*



For the third consecutive year, MSHA reported that the most common violation at surface metal mines in 2016 involved housekeeping in workplaces, passageways, storerooms, and service rooms, or standard 56.20003(a). Prior to its number one ranking, the housekeeping standard was the third most frequently cited standard and violations relating to electrical conductors, 56.12004, was most frequently cited.

At surface nonmetal operations, violations involving guarding for moving machine parts, standard 56.14107(a), was the most cited in 2016. This was the second and third most cited regulation in 2015 and 2014, respectively. A link to the coordinating standard describing the violation can be found <u>here</u>.

Below you will find the top 10 most common cited standards for surface metal and nonmetal mines in 2016. 2017 data has not been released yet.

March is Part 46 Training Month at OIAA

We will be holding two separate classes back to back, one in Albany and one in Roseburg. The difference this year is that we are limiting the number of attendees in each class. Once again this year the class will be taught by the Law office of Adele Abrams. The dates and locations are listed below:

Coffee and sign-in is at 7:30 the class will start promptly at 8:00 AM Lunch will be served at noon and the class will continue thru at least half of that lunch break. Please do not leave the class until you have received and signed your certificate at the end.

Starting in 2018 this will be a "Refresher Training" class only. If you have new miners they may attend and this course material will count towards the new miner training, but it will not cover all of it. Each company will need to provide the additional training required for their new miners.

The type of membership your company has defines how many employees you can send to the **training at no cost**. Each person on your list must be an employee for your company and receive payroll wages from your company. Hired outside consultants and subcontractors are not considered employees and will need to register as either a Member or Non-Member company.

The different types of memberships are listed below.

Premier Corporate Membership attendance will be free for all YOUR employees.

<u>Corporate Membership</u> attendance will be free for the first 10 employees. The cost for each additional employee will be \$100.00. You will be billed for the additional attendees after the training is completed.

<u>Associate Membership</u> attendance will be free for your first employee. The cost for each additional employee will be \$ 100.00. You will be billed for the additional attendees after the training is completed

"Safepro MSHA Law Institute

Safepro Institute will give you the information and knowledge to not only comply with MSHA law but to combat citations with which you do not agree. The institute covers the 1977 Mine Health and Safety Act as amended by the 2006 Miner's Act and 30 CFR standards. We will go into detail about Your Company's responsibilities under the law and operator entitlements and inspector's responsibilities pertaining to the law. We will review what constitutes a S&S citation and 104d1 citation. You will be given a law manual which includes the two parts of the law and MSHA program policies. We will review a number of actual citations that have been issued over the years and how to defend against bad paper using the law manual. The seminar will cover part 46 training requirements and part 50 reporting requirements. By attending our institute, you will have the knowledge and confidence to handle the "imminent" MSHA inspection. Have your game plan and your people ready; remember your house must be in order to keep government from controlling your business.

The June 2018 Safepro Institute will be held at the Harrah's Cherokee Casino Resort in Cherokee North Carolina. A block of rooms has been held for the class at the Harrah's Cherokee Casino Resort. A special rate has been arranged. Breakfast and lunch will be served all four days at no charge. There will be four full days of class getting out of class on Thursday around 4:30. All you will need for class are pen and notepaper. Dress for the class will be casual.
