The Environmental Management System (EMS) Guide was published in the fall of 2012 to provide guidance for the development and implementation of an EMS for small to medium sized hard rock mining operations. With all the additional regulations that have hit and are suspected to hit the industry in the next decade, utilizing and following an EMS is a viable asset to a business. The document details the implementation process in a step-by-step manner as well as policy suggestions to maintain consistency from employees to management to ownership. The intent is to provide visibility to the environmental aspects that the facility may impact and place adequate controls and metrics to achieve regulatory compliance. However, the implementation of an EMS is only as successful as the monitoring program that follows to assess performance.
