## Chairman's Message

We are encouraged by responses from a few members willing to step up and help OIAA continue to serve the industry. Hopefully a few more of you can join us and lend a hand. In national regulatory news, the Trump-era definition for Waters of the United States (referred to as the "Navigable Waters Protection Rule") was vacated last year through a court case in Arizona. This month, the US Army Corps of Engineers announced it is reverting all decisions to the pre-Obama interpretation of WOTUS. This is an infamously unclear definition. Both the Obama and Trump administrations tried to address this, though in different directions.

The most significant effect for now is that any previous determination of federal-jurisdiction waters on your proposed mine site will now be re-interpreted by the older standard. Unless you already had your permit approved, onsite waters (wetlands, streams, etc.) could now be re-interpreted to be under federal jurisdiction and could impose different standards for an approved permit.
