Chairman's Message


Update on Workplace Examinations Rule – MSHA delayed the effective date of its revised Workplace Examination rule, which should have been halted by President Trump's executive order in January. MSHA has said the rule was still "scheduled to become effective" on May 23, 2017. However, on May 22, MSHA posted that the rule would be delayed until October 7, 2017. (Nice timing...) Its future is still uncertain and still has to survive several legal challenges. The fact that MSHA is currently operating without an appointed administrator does not help their cause. The Positive Impact of Aggregates – A recent study published by the Phoenix Center in Washington D.C. summarizes the positive contributions aggregate mines make to the economy and their local communities. The results are presented as a "scorecard" with data analysis and summary that help communicate the value of aggregate mining. For example: "...each job in the aggregates industry supports an additional 4.87 jobs throughout the economy. These jobs are widely spread across industries and occupations. Each dollar of earnings (i.e., wages) creates another \$4.19 of earnings in other sectors, and each dollar of sales in the industry produces another \$3.47 of sales in other industries." OIAA 2018 Part 46 Training

Mark your calendars. Dates have been set for our Annual Part 46 Training. The Law office of Adele Abrams will conduct the training. Registration forms will be available starting January 15th. Policy changes have been made for 2018, please read below for the new changes.

Changes have been made to our Annual Part 46 Training Registration Process

Starting in 2018 this will be a "Refresher Training" class only. If you have new miners they may attend and this course material will count towards the new miner training, but it will not cover all of it. Each company will need to provide the additional training required for their new miners.

<u>Registration will be on a first come first served basis this year</u>. Registration forms will be accepted starting January 15th, 2018. If you want a particular location you must sign up early to insure you get your location. Late entrants will be offered space available only.

Premier Corporate Membership attendance will be free for all YOUR employees.

<u>Corporate Membership</u> attendance will be free for the first 10 employees. The cost for each additional employee will be \$100.00. You will be billed for the additional attendees after the training is completed.

<u>Associate Membership</u> attendance will be free for your first employee. The cost for each additional employee will be \$ 100.00. You will be billed for the additional attendees after the training is completed

This training is for OIAA Member Employees only. If you have subcontractors working for you and you send them to the training they will need to register under their company name and pay the non-member fee. Only if they are on your company payroll are they considered your employees.

Every day approximately 13,000 Americans are injured each day in the workplace. Preventable injuries are the fourth leading cause of death in the United States.

June is National Safety Month and the perfect time to make job site safety your priority. Here are five basic tips to help you focus on safety in the workplace

- Take advantage of available safety training.
- Stay alert: know your work area and equipment.
- Follow guidelines of safe equipment preparation, start-up, operation, and maintenance.
- Be an example for your well-being and the protection of others. Encourage co-workers to be safe too!
- Think about what is important to you. Your family and friends depend on you to make it home safely every day!

Heat Stress Prevention

As spring turns into summer and brings up "hot weather," we should all be aware of some tips to prevent heat stress. Remember, physical activity at high temperatures can directly affect health and indirectly be the cause of accidents

What is Heat Stress?

It's a signal that says the body is having difficulty maintaining its narrow temperature range. The heart pumps faster, blood is diverted from internal organs to the skin, breathing rate increases, and sweating increases, all in an attempt to transfer more heat to the outside air and cool the skin by the evaporation of sweat. If the body can't keep up, then the person suffers effects ranging from heat cramps to heat exhaustion, and finally to heat stroke

Dry clothes and skin doesn't mean you're not sweating!

In dry climates you might not feel wet or sticky, but you are still sweating. On a very warm day you can lose as much as two liters of fluid. Beat the heat. Help prevent the ill effects of heat stress by:

Drinking water frequently and moderately (about a glassful every 15-30 minutes). Due to the fact that most of us already consume excess salt in our diets, salt tablets are not recommended for general use

Resting frequently.

Eating lightly.

Doing more strenuous jobs during the cooler morning hours.

Utilizing ventilation or fans in enclosed areas.

Remembering that it takes about 1-2 weeks for the body to adjust to the heat; this adaptation is quickly lost – so your body will need time to adjust after a vacation, too.

Avoiding alcohol consumption. Many cases have occurred the day after a "night on the town."

Wearing light-colored, cotton clothes and keeping your shirt on – desert nomads don't wear all those clothes for nothing

Who May Apply?

Your Personal Statement is the most important part of your application! Your statement should be a minimum of one page and not more than two pages.

The OIAA Selection and Award Process

Applications will be directed to the scholarship selection committee. Scholarship recipients will be notified in writing by the OIAA and the recipient's name will be listed on the OIAA website. Those who do not receive scholarships will also be notified by mail.

Unless otherwise noted, the scholarships shall be in the amount of \$ 2,500.00 each as a onetime award.

All recipients will be required to write a short letter of thanks to the OIAA and present it in person at a designated Board Meeting. By attending such meeting you indicate your acceptance of the award and the terms of the scholarship.

Scholarships shall be awarded in compliance with applicable Oregon laws and OIAA policies related to non-discrimination on the basis of sex, race, age, color, national or ethnic origin, marital status, disability, religion, sexual orientation or veteran status.
