#### Stormwater Reminder

Now that the rains are here, remember to check your site's stormwater management systems and make sure they are effective in preventing sediment and contaminants from reaching surface waters and groundwater. If your site discharges stormwater to a stream or other surface water, you need to conduct monitoring and record activities for your NPDES 1200-A permit. If you need a refresher, look back at the June 2022 newsletter for more information, or access information through DOGAMI's website:

In addition to turbidity and required water sampling, look for sheens leaving equipment yards, roadways, or other traveled surfaces and clean them up to make sure they do not reach the outside environment.
