Chairman's Message

Earlier this month OIAA sent out an email to our members about MSHA seeking comments on whether to continue to delay the new workplace exams rule. This rule has been in uncertain status after being released by MSHA on January 17 — and effectively being placed on hold by President Trump's executive order suspending new regulations on January 20 (see the February 2017 newsletter for summary). It is not clear if the executive order alone can hold this off, since the order included a clause allowing new regulations to be published if there are "urgent circumstances relating to health [and] safety". The effective date for the rule was to be May 23. That seems unlikely, but the rule is not yet dead.

We urge our members to send comments on the rule to MSHA before the <u>deadline on April 26</u>. Comments should refer to rule RIN 1219-AB87 and be emailed to <u>zzMSHA-comments@dol.gov</u> or left online at <u>www.regulations.gov</u>.

MSHA Website Safety Alert

METAL/NONMETAL MINE FATALITY – On March 14, 2017, an independent owner/operator truck driver, walked behind his raised end-dump trailer, while dumping his load and was engulfed by sand.



Best Practices

- o Conduct pre-operational checks to identify any defects that may affect the safe operation of equipment before it is placed into service.
- Ensure workers who operate heavy equipment are adequately informed, instructed, trained and supervised.
- Do not position yourself near a truck that is actively dumping, or near a truck while it is raising
 its bed.
- Ensure that the tailgate is unlocked before elevating the cargo box to the dump position.
- Do not attempt to dump the material if it sticks in the bed. Stuck material can imbalance the load and affect the stability of the truck. Always deflate trailer air springs prior to raising the dump body

This is the 2nd fatality reported in calendar year 2017 in metal and nonmetal mining. As of this date in 2016, there were two fatalities reported in metal and nonmetal mining. This is the 1st Fall of Material fatality in 2017. There was one Fall of Material fatality in the same period in 2016.

Safepro Law Institute coming to Savannah June 5 – 9 By Dean Beam

A federal appeals court decision has rejected MSHA's argument that the Mine Act gave it authority to take enforcement against a manufacturing plant making and repairing mine equipment, saying that instead the shop falls under OSHA jurisdiction. The <u>decision</u> limits the scope of what is defined as a mine operation under federal law and therefore what types of workplaces MSHA can inspect.

The CRA provides the opportunity for Congress to pass a resolution of disapproval within 60 days of receiving a final copy of a rule or the rule being published in the Federal Register. The President then has the ability to veto Congress' vote of disapproval or sign the resolution, thereby eliminating the rule. This may impact work place examination rule stay tuned.

Proposed budget cuts would cut DOL's budget to \$9.6 Billion – down from the \$12.2 Billion budget for 2017. Unsure at this time what this may lead to for MSHA if anything.

While MSHA continues to issue citations and orders, it is essential that mine operators are aware of their rights. The Mine Act of 1977 governs all mine operators and grants MSHA authority over the industry. It, along with the MINER Act of 2006, also specifically the rights of miners and operators. A better understanding of these powers and authority provides operators the ability to deal with MSHA and when needed exercise their rights during inspections. \$afepro covers the 1977 Act in detail along with 30 CFR and program policies which give guidance to how the laws and regulations are to be enforced. The upcoming institute in Savannah June 5 - 9 will give you the knowledge coupled with your mining experience that allows you to be prepared for the imminent MSHA inspection. The Institute information will help you avoid bad citations and the knowledge to comply with the law. You will add value to yourself and your company by attending! Unless otherwise noted, the scholarships shall be in the amount of \$ 2,500.00 each as a onetime award.
