Chairman's Message

MSHA Enforcement Alert! – We have heard from a couple of our members about new inspectors in Oregon that have been aggressive and confrontational. In the words of one of our members, their equipment operator was being "cornered" by aggressive, repeated questioning that insinuated he was lying. The member likened the approach to a police interrogation, where repeated questioning would hopefully result in inconsistent answers.

An operator may be tempted to lie if he knew of some potentially damaging details. (But let's be clear, folks – DO NOT lie to federal inspectors!) In this case, however, the operator could easily and honestly answer each time he was asked the same questions throughout an inspection, which took most of the day. The Albany Field Office has been informed about these unnecessarily confrontational inspection tactics. It does not serve to promote safety in the industry by building mistrust between operators and inspectors.

If you or your staff participate in an inspection, remember to truthfully answer the questions that are asked. If the questioning turns confrontational or insinuates dishonesty, do not lose your cool. Answer the questions and note what is being asked and how you are answering the questions. If this style of inspection continues, it will be helpful to bring specific examples to the attention of the Albany Field Office or higher up the administrative chain, if it comes to it. Please share your experiences with OIAA Board members so we can keep tabs on how frequently this is occurring.
