Staying Vigilant: Preventing Complacency as the Seasons Change

As autumn approaches, it brings with it a shift in weather patterns and worksite conditions that can challenge even the most experienced operators. The fall season is often associated with a rise in complacency regarding safety; an understandable but preventable tendency as routines settle in and environmental factors begin to change.

Operators and employees alike must remain diligent in following established best practices to ensure safety across all aspects of daily operations. The goal is simple yet critical: every employee should return home in the same condition as when they arrived.

Changing Seasons, Changing Risks

Across both public and private sectors, organizations frequently see an increase in *Near Miss Reports* during transitional seasons such as fall. These incidents often stem from a combination of adverse conditions, momentary lapses in judgment, or sheer misfortune.

A recent *Fatality Alert* published by the Mine Safety and Health Administration (MSHA) serves as a sobering reminder of the consequences of such conditions. According to the alert, a contract hauler was dumping a load of aggregate on a stockpile when the pile gave way, causing the truck to overturn. Tragically, the driver later succumbed to injuries sustained in the incident.

This marks the 22nd mining-related fatality recorded in 2025—a statistic that underscores the ongoing importance of vigilance and proactive safety culture within our industry.

Reinforcing Best Practices

In ever-changing surface mine environments, safety protocols must be more than procedural; they must be habitual. A few critical best practices include:

- Maintain stable stockpile slopes and avoid oversteepening.
- Never undercut stockpiles during loading operations.
- **Dump only from stable, secure locations** with proper visibility.
- Conduct workplace examinations before and throughout each shift.
- Establish and maintain stable berms wherever equipment overturning is a potential risk.

These examples are not exhaustive, but they highlight the ongoing attention required to manage dynamic and potentially hazardous work conditions effectively.

A Call to Collective Responsibility

Safety is not a seasonal priority; it is a daily commitment. As professionals, we must continue to foster a culture of accountability, resist the temptation toward complacency, and remain watchful for one another in every task we perform.

The conditions in our workplaces will always evolve, but our responsibility to return home safely at the end of each day is non-negotiable.

Wishing everyone a safe and mindful transition into the fall and winter months.

MINE FATALITY – A contract haul truck driver was injured while dumping a load of material at the top of a stockpile. The ground under the truck failed causing the truck to overturn onto its cab. The driver died later from his injuries.



BEST PRACTICES

- Construct substantial berms, bumper blocks, safety hooks, or similar impeding devices at dumping locations where there is a hazard of over travel or overturning.
- Conduct workplace and ground condition examinations before beginning work in an area.
- Always dump material from a stable and safe location. If examinations indicate the ground conditions are not reliable, dump loads at a safe distance and push the material over the edge using a bulldozer.
- Never load material from the toe of a stockpile that is below an active dump point. This
 typically leads to a slope that is unstable and too steep.
- Maintain stockpile slopes no steeper than the angle of repose.
